## Location

The College Courts Housing Complex consists of twelve buildings with twelve apartments per building. The complex is located off Waldrop Drive near the northwest corner of the campus and is approximately four blocks from the center of campus.

## Description of the Apartments

One hundred and thirty-two (132) of the apartments are one-bedroom apartments. They have a combination living and dining room, a bath, two full-sized closets and a linen closet. The furnishings include the following: dining table and dining chairs, electric range and refrigerator, coffee table, end tables, arm chair, sofa, bedroom suit of double dresser and mirror, chest of drawers, bookcase bed with mattress and box springs (two twin beds in apartments for unmarried students); the bath has a tub with a shower. The phone line is furnished with each apartment.

Twelve of the apartments have two bedrooms with the same furnishings as the one-bedroom apartments, except the extra bedroom has twin beds. Each apartment building has two utility rooms which are equipped with coin-operated washers and dryers. The buildings are of concrete block and brick construction. All apartments are air-conditioned and have electric heat.

**THE APARTMENTS ARE FURNISHED, AND UNIVERSITY FURNISHINGS MAY NOT BE REMOVED FROM THE APARTMENT. NO PETS ARE ALLOWED.**

## Other Important Information

These apartments are available for married students, single parents with children, graduate students, non-traditional students and undergraduate students who are at least 21 years of age by the first day of registration.

Graduate students, non-traditional students, and undergraduate students (over 21) should apply with a roommate for College Courts if one is desired. Roommates will not be assigned by the Housing Office. A student may request an apartment without a roommate if space is available and there isn't anyone on the waiting list for an apartment. The student, however, will be responsible for the entire amount of rent for the unit.



## Eligibility

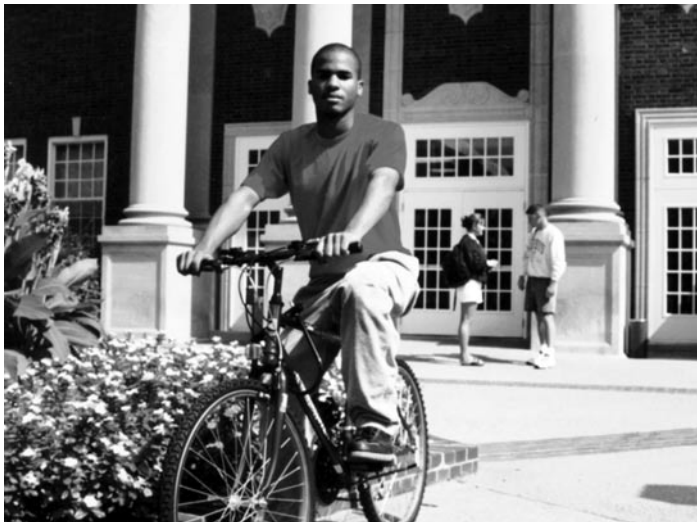
To be eligible to apply for College Courts, a student must submit an application with a deposit to the Housing Office. All requests will be reviewed and evaluated, and acceptance will be determined by the Housing Office.

Two bedroom apartments will be reserved solely for married students with children. A maximum of four family members may reside in the two bedroom apartments.

One-bedroom apartments will be reserved on the following priority basis:

- **Priority #1: Married students who have either two or three family members.** Only after exhausting the waiting list for family applicants will apartments be assigned to others.
- **Priority #2: Graduate students who are at least twenty-one (21) years of age.**
- **Priority #3: Non-traditional students regardless of class status.** Non-traditional students are defined as those who have been out of school for at least four years and are 23 years of age or older.
- **Priority #4: Undergraduate students who are at least 21 years of age.**
- **Priority #5: Faculty and staff members, whether permanent or temporary status.**

When assigned, you will receive a confirmation letter. If you do not get an apartment, you may stay on the waiting list or cancel your application.



### *Other considerations*

1. A student's age will be calculated by the age the student has attained by the first day of regular class registration.
2. Only two students can reside in a one-bedroom apartment. Anyone found in violation will be asked to move out of College Courts immediately.
3. All residents of College Courts must abide by University policies and regulations.
4. All students residing in College Courts must maintain full-time status. In the case of a married couple, either the husband or the wife must be a full-time student.
5. The contractual period of occupancy for College Courts apartments is the semester of, or the following semester for which the contract is signed. Students may not move from their apartment during the semester. Students who do move will be assessed for the semester rent due.
6. Sub-leasing of space is not permitted.

A \$150 deposit must accompany your application for College Courts housing. The deposit will be refunded when you move from the apartment, less any charges, if you have provided a thirty day written notice, and have lived in the apartment for the contracted period. All utilities are furnished with the exception of long distance telephone calls. Rent is subject to change by action of the MSU Board of Regents.

## **MURRAY STATE UNIVERSITY HOUSING DISABILITY ASSIGNMENT APPEAL PROCESS**

### **Housing Disability Assignments**

A student with a documented disability or a parent or advocate on behalf of the student and with the student's permission may make a written request for reasonable housing accommodation(s) or a housing exemption. Said request should include appropriate documentation of the student's disability. The request for the housing accommodation or exemption form will be available in the Housing Office.

The request form shall be forwarded to the ADA Subcommittee of the Affirmative Action Committee, 103 Wells Hall, Murray State University, Murray, KY 42071, for a determination. The decision of the ADA Subcommittee of the Affirmative Action Committee will then be mailed by the Office of Equal Opportunity to the student. Please note that the resulting housing assignment, if any, is mailed by the Housing Office. It should be noted that requests for accommodations can be initiated at any time. However, it is recommended that requests for the fall semesters be received by June 30; for spring semesters by December 15; and for summer terms, one month prior to the first day of class.

Requests for accommodations or a housing exemption made after the start of any semester or term shall be processed in like manner. A determination shall be made as soon as possible but no later than two (2) weeks following the date the request is received.

### **Housing Disability Assignment Appeals Process**

A student (or the student's parent or advocate on behalf of the student) who is dissatisfied with the decision of the Subcommittee as to the requested accommodation(s) or housing exemption (i.e. does not believe that the housing assignment or denial of exemption accommodates the student's disability or in some way endangers the student's safety or health) may file a written appeal to the Office of Equal Opportunity, 103 Wells Hall, Murray State University, Murray, KY 42071, along with any supporting documentation. Said appeal shall be filed in the Office of Equal Opportunity within ten (10) days from the date of receipt of the original decision by the Subcommittee as to the request for reasonable accommodation(s)/housing exemption. No one involved in the initial decision by the Subcommittee shall be involved in the determination on appeal which shall be made by the Office of Equal Opportunity. The Office of Equal Opportunity shall make a written determination within thirty (30) days from the date it received the appeal. The decision of the Office of Equal Opportunity shall be final.
