<u>Jackie Dudley, Vice-President for Finance and Administrative Services:</u> Jackie Dudley gave an update on Curris Center parking. The lot will close on June 10 for construction. The contract for Primary Care will be completed soon planned opening is June 1 and will have summer hours of 9am to Noon. Vendors have toured to research outsourcing for custodial and grounds positions. This is in the initial stage and no RFP has been completed. The pension situation is still an unknown.
