



SGA CONSTITUTIONAL AMENDMENT PROPOSAL (Bill 90-25-B2)

Introduced: October 22, 2025

Passed: October 29, 2025 (Unanimously)

Current Statement

ARTICLE II. OFFICERS

Section 2. The President shall be the Chief Executive Officer of the S.G.A. and serve as the Student Regent on the university Board of Regents. The qualifications for the office require one to be a full time student at the time of election and thereafter. In addition, the President shall have attained at least Junior Class standing the fall semester following the election. The President's duties and powers shall be to serve as President of the Student Senate and to serve as an ex-officio member of all S.G.A. committees, councils, and boards. The office holder shall maintain these standards, as well as others prescribed in the by-laws, at the time of election and during the term of office.

Section 3. The Executive Vice President, whose qualifications shall be the same as those for President, shall serve as Vice President of the Senate and as Chairman of the Campus Activities Board.

Section 4. The Vice President of Administration shall serve as the Secretary of the Student Senate and Campus Activities Board. The Vice President of Administration must be a full-time student. The office holder shall maintain these standards, as well as others prescribed in the by-laws, at the time of election and during the term of Office.

Section 5. The Vice President of Finance shall serve as the Treasurer of the S.G.A. and monitor all funds received from the University. The Vice President of Finance shall be a full-time student. The office holder shall maintain these standards, as well as others prescribed in the by-laws, at the time of election and during the term of office.

Revised Statement

ARTICLE II. OFFICERS

Section 2. The President shall be the Chief Executive Officer of the S.G.A. and serve as the

In addition, the President shall have attained at least Junior Class standing the fall semester following the election. **In addition, the President must have served in a branch of SGA for at least one (1) year.** The President's duties and powers shall be to serve as President of the Student Senate and to serve as an ex-officio member of all S.G.A. committees, councils, and boards. The office holder shall maintain these standards, as well as others prescribed in the by-laws, at the time of election and during the term of office.

Section 3. The Executive Vice President, whose qualifications shall be the same as those for President, shall serve as Vice President of the Senate and as Chairman of the Campus Activities Board.

Section 4. The Vice President of Administration shall serve as the Secretary of the Student Senate and Campus Activities Board. The Vice President of Administration must be a full-time student. **In addition, the Vice President of Administration must have served in one branch of SGA for at least one (1) semester.** The office holder shall maintain these standards, as well as others prescribed in the by-laws, at the time of election and during the term of Office.

Section 5. The ~~Vice President of Finance~~ **Vice President of Student Connections** shall serve as the Treasurer of the S.G.A. and monitor all funds received from the University. The Vice President of Finance shall be a full-time student. **In addition, the Vice President of Student Connections must have served in one branch of SGA for at least one (1) semester.** The office holder shall maintain these standards, as well as others prescribed in the by-laws, at the time of election and during the term of office.


Reason for the revision of the Murray State Constitution
