

## Higher Education Emergency Relief Fund (HEERF) Reporting - Cares Act Emergency Financial Aid Grants to Students

1. Murray State University signed and returned the 'Recipient's Funding Certification and Agreement' for the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act on **April 13<sup>th</sup>, 2020**. Murray State University will spend no less than 50% of the funds it receives under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. Murray State University will receive **\$3,135,385** under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students. This amount represents 50% Murray State University's total allotment under the legislation.
3. As of **September 30, 2020, \$1,773,684.95** has been distributed to students.
4. Murray State University estimates around **6,000** students are currently eligible to participate in programs under Section 484 in the Title IV of the Higher Education Act of 1965.
5. As of **September 30, 2020, 2,125** students have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act.
6. Murray State University's methodology for distributing funds under the CARES Act:
  - a. All students at Murray State University were able to apply for funds through the myGate Student portal. The application collected the following information: (1) Time of Application, (2) Murray State Student ID Number, (3) Name, (4) Murray State Email Address, (5) Confirmation student incurred expenses related to the disruption of campus operations due to coronavirus including eligible expenses associated with cost of attendance such as food, housing, course materials, technology, health care, and child care (6) Estimate of incurred expenses, and (7) Certification that information provided was true and correct.
  - b. Applications will be evaluated to confirm eligibility and reviewed for approval by an appointed committee. The awards will be based on the amount the student requested and the max award will be determined by the number of eligible expected applications.

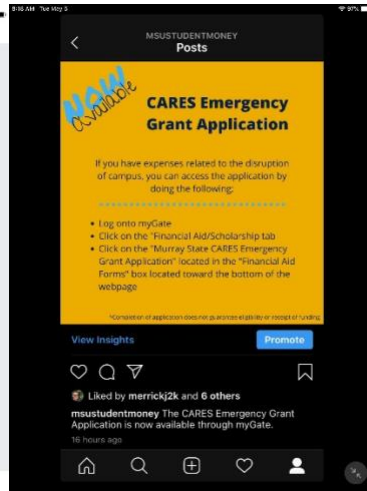

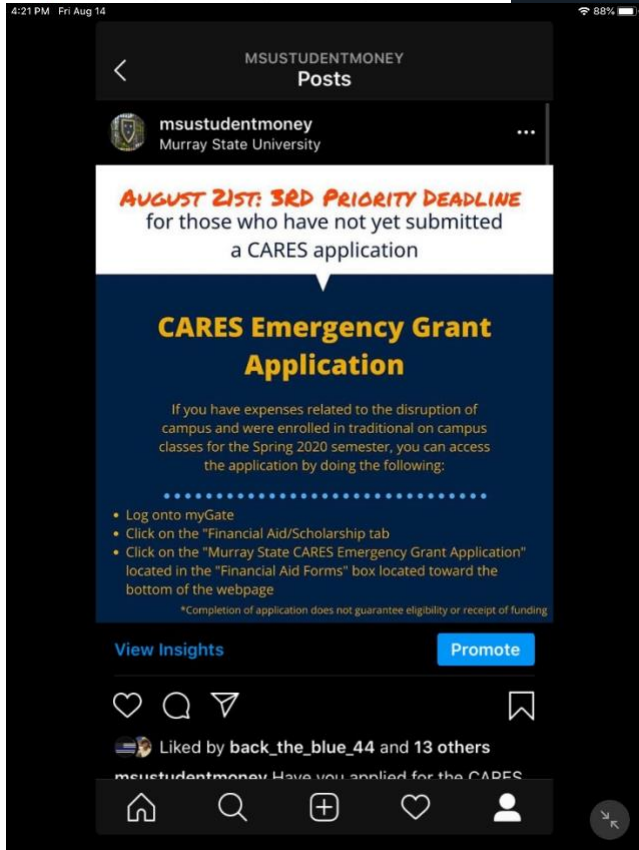
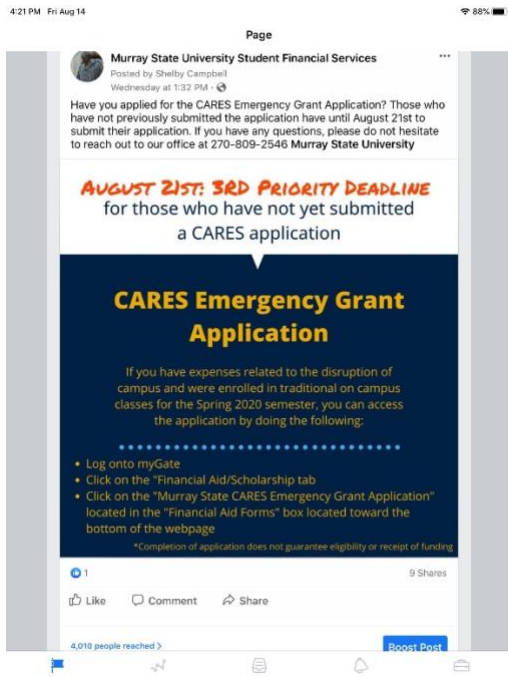
